- 3 Ensure that Luxembourg continues to attract international investment, companies and skills that are a perfect fit for the country

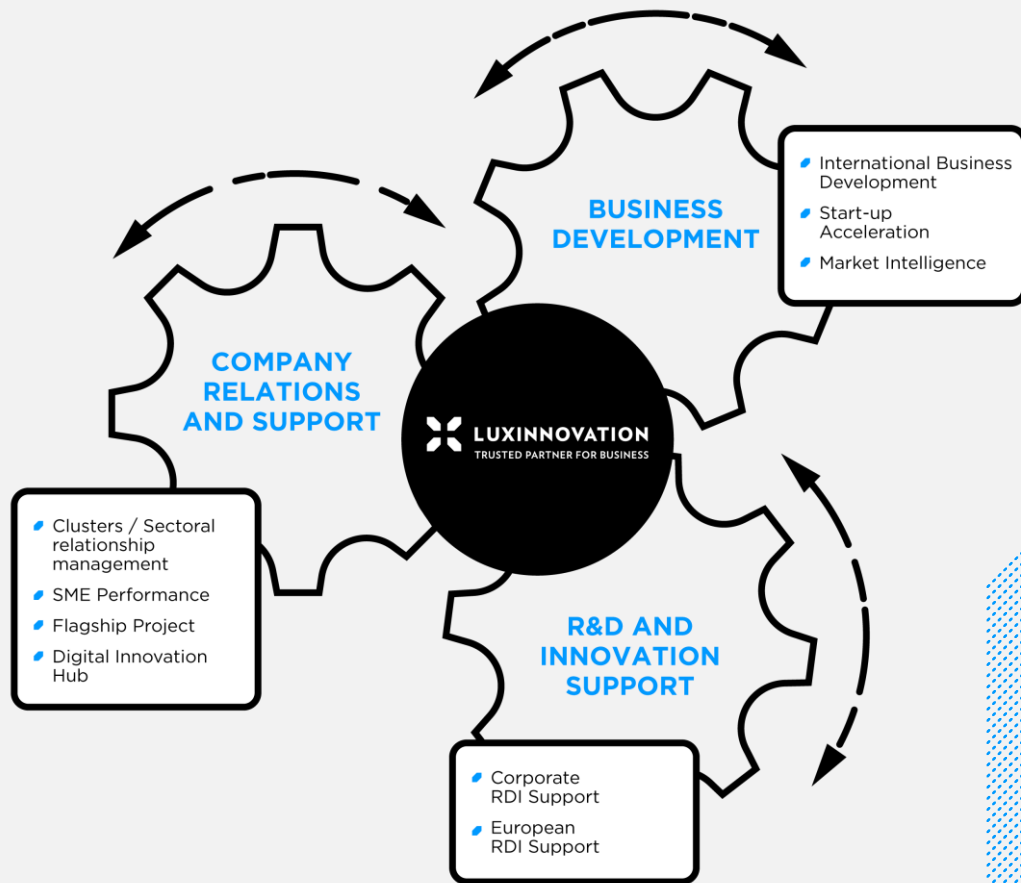

Collaborate constructively with all actors of Luxembourg's economy so that forces can be united in a manner to advance Luxembourg's economic development in a sustainable and efficient manner



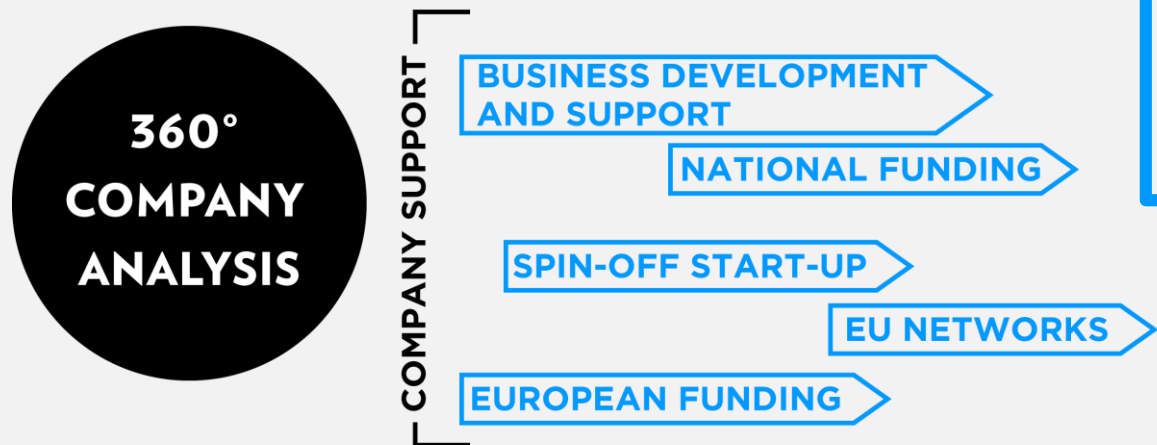

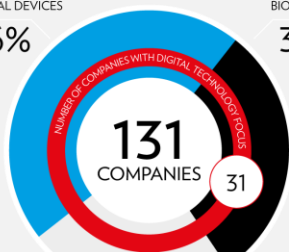

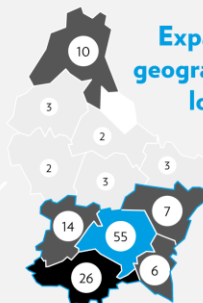
